Selection of Monitoring and Evaluation Expert for GEF 7 funded project on "Strengthening forest management for improved biodiversity conservation and climate resilience in the Southern Rangelands of Kenya"

## 1.0. Background Information

The Global Environment Facility (GEF)-funded project on "Strengthening forest management for improved biodiversity conservation and climate resilience in the Southern Range lands of Kenya" is to be implemented by NEMA in close coordination with the International Union for the Conservation of Nature (IUCN). The project is being implemented over 4 years, primarily in Kajiado and Narok Counties. The overarching goal of the project is to support a functioning and resilient dryland forest landscape that supports sustainable economic/food production through integrated natural management. The project's overall objective is to restore Southern Kenya's dryland forest and rangeland landscape for a resilient environment and community livelihoods. This will be delivered through the following objectives:

- i. To develop Community enterprises and livelihood value chains based on sustainable use of natural resources in the drylands.
- ii. To improve effective governance of land resources through the strengthening of community-level organizations and national and County governments.
- iii. Implementation of local resources management and restoration plans by the community units and Local Authorities.
- iv. To coordinate the management of an integrated dryland landscape knowledge exchange and management platform.

## These objectives will be realized through three key components that include;

- Strengthening the enabling environment for the sustainable management of drylands;
- 2. Investment in scaling up sustainable dryland management;
- 3. Programmatic coordination, monitoring and knowledge management.

The project has been designed in careful consideration of the national priorities of Kenya, the needs of the local pastoral Community and the lessons from past and on-going initiatives in similar ecosystems. The proposed holistic approach will link income-generating activities (e.g. livestock marketing, horticulture value chain, eco-tourism) with sustainable environmental management activities. Therefore, the project plans to create a bridge between development needs and environmental activities. By building the communities' capacities and supporting them to derive more benefits from sustainable activities, the project will pave the way for innovations at local or landscape level in terms of natural resources management and conservation.

Under Component 3 of the project on Programmatic coordination, monitoring, and knowledge management the project will put in place and institutionalize robust and integrated monitoring systems to determine the status of land degradation, climate change trends, forest cover change and connectivity, the status of wildlife populations, and the socio-economic status of the people that use the landscape. Performance and impact are two central aspects that guide the M&E of projects. While the evaluation of performance concentrates on the efficacy and efficiency of the project, the evaluation of impact focuses on the changes that the project generates in the context in which it works. The analysis of performance looks within the project, while that of impact looks outside it.

M&E should endeavour to undertake a more participatory, more realistic, and more relevant approach to describing the reality of the project's progress and outcomes. That is why the project proposes to implement a Monitoring and Evaluation system at two different levels: at the community level and County and National level. Participatory M&E needs to examine with the main stakeholders what constitutes progress to include the perceptions of the target population. It can, therefore, provide more comprehensive information on efficiency, relevance, sustainability, impact, and effectiveness of work in progress. It is relevant to consider sites with and without the project to be able to assess the real impacts of the project. It is important to be able to describe and distinguish between the effects resulting from the project and the effects resulting from local changes independent of the project. Indicators to consider need to be SMART: Specific, Measurable, Achievable, and Attributable. Relevant and Realistic and Timebound, Timely, Trackable, and Targeted.

Ensure all project activities are continuously monitored evaluated, reported and lessons learnt are documented.

Under the immediate supervision of the Programme Coordinator, the M&E Specialist will perform the following tasks:

- i. Develop and enhance sector-specific monitoring and evaluation frameworks for the various project components.
- ii. project team in developing program processes, outputs, outcomes, and impact level indicators for progress monitoring;
- iii. Based on the framework develop a simple and user category-wise monitoring format and guidelines to be used in the monitoring process.
- Guide the Project team in implementing the M&E framework, guidelines, and other M&E tools
- v. Guide the Project team in preparing an annual monitoring and evaluation plan consistent with the M&E Framework
- vi. Develop testing, modifying, and finalizing Recording and Reporting Forms and Formats for program components.
- vii. Conduct an M&E need identification survey among partner organizations at the site level and identify M&E capacity gaps
- viii. Capacity Building on M & E Techniques as may be required
  - ix. Prepare quarterly, Annual and field Reports as may be required
  - x. Spearhead documentation of lessons learnt annually
